Providing for consideration of the bill (H.R. 5107) to protect crime victims' rights, to eliminate the substantial backlog of DNA samples collected from crime scenes and convicted offenders, to improve and expand the DNA testing capacity of Federal, State, and local crime laboratories, to increase research and development of new DNA testing technologies, to develop new training programs regarding the collection and use of DNA evidence, to provide post-conviction testing of DNA evidence to exonerate the innocent, to improve the performance of counsel in State capital cases, and for other purposes.

Actions Timeline

- **Oct 6, 2004:** The House Committee on Rules reported an original measure, H. Rept. 108-737, by Mrs. Myrick.
- **Oct 6, 2004:** Placed on the House Calendar, Calendar No. 239.
- **Oct 6, 2004:** Rule provides for consideration of H.R. 5107 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. A specified amendment is in order.
- **Oct 6, 2004:** Considered as privileged matter. (consideration: CR H8175-8177)
- **Oct 6, 2004:** DEBATE - The House proceeded with one hour of debate on H. Res. 823.
