Waives a specified requirement of rule XIII to provide for consideration or disposition of: (1) a bill or joint resolution making continuing appropriations for FY 2005, an amendment thereto, or a conference report thereon; or (2) a bill or joint resolution making general appropriations for such fiscal year.

- **Nov 20, 2004:** DEBATE - The House proceeded with one hour of debate on H. Res. 846.
- **Nov 20, 2004:** The previous question was ordered without objection. (consideration: CR H10085)
- **Nov 20, 2004:** POSTPONED VOTE - At conclusion of debate on H. Res. 846 the chair put the question on adoption of the resolution and by voice vote announced that the ayes had prevailed. Mr. Hastings (FL) objected to the vote based on the absence of a quorum and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day. The point of no quorum was considered as withdrawn.
