- Nov 20, 2004: POSTPONED VOTE At the conclusion of debate on H. Res. 866 the Chair put the question on adoption of the resolution and by voice vote announced that the ayes had prevailed. Mr. Baird objected to the vote based on the absence of a quorum and the Chair postponed further proceedings on the question of agreeing to the resolution until later in the legislative day. The point of no quorum was considered as withdrawn.
