Providing for consideration of the bill (H.R. 4844) to amend the National Voter Registration Act of 1993 to require any individual who desires to register or re-register to vote in an election for Federal office to provide the appropriate State election official with proof that the individual is a citizen of the United States to prevent fraud in Federal elections, and for other purposes.

Sets forth the rule for consideration of H.R. 4844 (Federal Election Integrity Act of 2006).

Actions Timeline

- **Sep 20, 2006:** POINT OF ORDER AGAINST CONSIDERATION - Mr. McDermott stated that the provisions of H. Res. 1015 violate the Congressional Budget Act of 1974 by imposing an unfunded mandate and made a point of order against the consideration of the resolution. Subsequently, the Chair noted that the required threshold of identifying the specific language in question had been met, and the House proceeded with 20 minutes of debate on the question of consideration.
- **Sep 20, 2006:** On motion to consider the resolution Agreed to by the Yeas and Nays: 213 - 190 (Roll no. 454). (consideration: CR H6745)
- **Sep 20, 2006:** Considered as privileged matter. (consideration: CR H6742-6756)
