Summary (as of Sep 28, 2006)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Waives a specified requirement of Rule XIII (Calendars and Committee Reports) to allow consideration or disposition of the following measures on the same day they are presented to the House: (1) a bill to authorize trial by military commission for violations of the law of war; (2) a bill to update the Foreign Intelligence Surveillance Act of 1978; and (3) a conference report on H.R. 5441 (FY2007 Department of Homeland Security appropriations).

- Sep 28, 2006: DEBATE The House proceeded with one hour of debate on H. Res. 1046.
- Sep 28, 2006: POSTPONED PROCEEDINGS At the conclusion of the debate on H.Res. 1046, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Ms. Matsui demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption until later in the legislative day.
- Sep 28, 2006: UNFINISHED BUSINESS The Chair announced that the unfinished business was on the adoption of two previous rules on which further proceedings had been postponed.
