Summary (as of Apr 6, 2005)

(This measure has not been amended since it was introduced. The summary has been expanded because action occurred on the measure.)

States that the House of Representatives: (1) supports the goals and ideals of Financial Literacy Month; and (2) requests that the President issue a proclamation calling on the Federal Government, States, localities, schools, nonprofit organizations, businesses, other entities, and the people of the United States to observe the month with appropriate programs and activities.

Actions Timeline

- Apr 6, 2005: Mr. Gutknecht moved to suspend the rules and agree to the resolution.
- Apr 6, 2005: Considered under suspension of the rules. (consideration: CR H1797-1802)
- Apr 6, 2005: DEBATE - The House proceeded with forty minutes of debate on H. Res. 148.
- Apr 6, 2005: At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
