Korean Immigration Commemorative Coin Act - Directs the Secretary of the Treasury to mint and issue \$1 silver coins emblematic of the immigration of Koreans into the United States and the significant contributions of Korean Americans to this Nation.

Restricts such issuance to the one-year period beginning on January 1, 2011.
