Amends the District of Columbia Access Act of 1999 to authorize through FY2011 its public and private school tuition assistance programs.

Redefines "eligible institution" to include any private school located in the United States.

Limits federal funding for such public school and private school programs for FY2006 and each succeeding fiscal year.

Requires: (1) the annual congressional reporting requirement of the Mayor of the District of Columbia to be fulfilled by August 1 each year; and (2) the report to include the number of students applying for the program and the number graduating from it.
