Summary (as of Jul 28, 2005)

Expresses the sense of Congress that the Medicaid prospective payment system for federally-qualified health centers is critical to ensuring that both Medicaid recipients and the nation's uninsured population have access to quality affordable primary and preventive care services.

Recognizes the critical role of such health centers as an essential source of care for millions of Medicaid recipients and uninsured Americans and supports continuation of the prospective payment system in helping to maintain this system of care.
