Sets forth the rule for consideration of the resolution (H. Res. 22) expressing the sense of the House of Representatives that American small businesses are entitled to a Small Business Bill of Rights.

Actions Timeline

- **Apr 27, 2005:** Considered as privileged matter. (consideration: CR H2558-2562)
- **Apr 27, 2005:** DEBATE - The House proceeded with one hour of debate on H. Res. 235.
- **Apr 27, 2005:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 235 under the rule, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mrs. Matsui demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Apr 27, 2005:** Considered as unfinished business. (consideration: CR H2578-2579)
- **Apr 27, 2005:** On ordering the previous question Agreed to by the Yeas and Nays: 228 - 201 (Roll no. 138). (consideration: CR H2562, H2578-2579; text: CR H2562)
- **Apr 27, 2005:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H2558)
- **Apr 27, 2005:** On agreeing to the resolution Agreed to by voice vote. (text: CR H2558)
