Expresses appreciation for the role of the Holy See in combating religious intolerance and religious discrimination.

Encourages the United States to continue to serve in a leading role in combating anti-Semitism and other forms of religious intolerance and religious discrimination worldwide.

Acknowledges the role of *Nostra Aetate* in fostering interreligious dialogue and mutual respect, including, in particular, new relationships of collaboration and dialogue between Jews and Catholics.
