Sets forth the rule for consideration of the bill (H.R. 2863) making appropriations for the Department of Defense for the fiscal year ending September 30, 2006.

Actions Timeline

- **Jun 16, 2005:** DEBATE - The House proceeded with one hour of debate on H. Res. 315.
- **Jun 16, 2005:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 315, the Chair put the question on ordering the previous question on the resolution and by voice vote, announced that the ayes had prevailed. Mr. McGovern demanded the Yeas and Nays, which were subsequently ordered, and the Chair postponed further proceedings on the question until later in the legislative day.
