Sets forth the rule for consideration of the bill (H.R. 3057) making appropriations for foreign operations, export financing, and related programs for the fiscal year ending September 30, 2006.

Actions Timeline

- **Jun 28, 2005:** DEBATE - The House proceeded with one hour of debate on H. Res. 341.
- **Jun 28, 2005:** POSTPONED PROCEEDINGS - At the conclusion of debate on the resolution the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Hastings (FL) demanded a recorded vote and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
