(This measure has not been amended since it was reported to the House on December 13, 2005. The summary of that version is repeated here.)

Small Public Housing Authority Act - Amends the United States Housing Act of 1937 to exempt a small public housing agency from the requirement to prepare an annual public agency plan if the agency: (1) administers not more than a total of 250 dwelling units and section 8 vouchers; and (2) is not a troubled agency.

Requires an agency to: (1) continue to make an annual civil rights certification, and establish, and consult with, one or more resident advisory boards; and (2) conduct a public hearing to discuss agency goals and policies, and make the information available to the public at the the agency's principal office.
