**Summary** (as of Jul 20, 2006)

United States-India Peaceful Atomic Energy Cooperation Act - Exempts, subject to a specified determination by the President, from certain requirements of the Atomic Energy Act of 1954 exports of nuclear material, equipment and technology from the United States and reexports of such U.S.-origin items to India.

United States Additional Protocol Implementation Act - Authorizes the President to implement the 1998 Protocol Additional to the Agreement between the United States of America and the International Atomic Energy Agency for the Application of Safeguards in the United States of America, and designate which executive agency or agencies shall issue or amend and enforce regulations to implement the Protocol.
