**Summary** (as of Sep 28, 2005)

Suburban and Community Forestry and Open Space Program Act of 2005 - Amends the Cooperative Forestry
Assistance Act of 1978 to establish in the Forest Service the Suburban and Community Forestry and Open Space
Program, which shall provide cost-share grants to preserve private forest land, contain suburban sprawl, and support
value-added forest product industries in States in which less than 25 percent of the land is owned by the United States.
