## Summary (as of Jun 13, 2006)

Commends the leadership of former Canadian Prime Ministers Jean Jacques Chretien and Paul Martin and current Prime Minister Stephen Harper for their commitment to democracy, human rights, and freedom.

Expresses U.S. gratitude and appreciation for Canada's enduring friendship and leadership in the Global War on Terror.
