Declares that the House of Representatives: (1) recognizes that the important contributions of chemical scientists and engineers to technological progress and the health of many industries have created new jobs, boosted economic growth, and improved the Nation's health and standard of living; and (2) supports the goals of National Chemistry Week as founded by the American Chemical Society.
