Summary (as of Feb 16, 2006)

Disabled Veterans Adaptive Housing Improvement Act - Increases from: (1) \$50,000 to \$60,000 the maximum amount authorized to be provided by the Department of Veterans Affairs to certain disabled veterans for the construction of specially adapted housing; and (2) \$10,000 to \$12,000 the maximum amount authorized for specially adapted features in a home.

Requires the Secretary of Veterans Affairs to annually increase such amounts to reflect increases in the cost of residential home construction.
