Expresses the sense of Congress that: (1) for the past 40 years, Medicare has made significant medical, social, and economic contributions to our Nation; (2) the access to care provided by Medicare has changed the course of health outcomes for the elderly and those with disabilities preventing physical deterioration and preventing more individuals from slipping into poverty; and (3) Congress must continue to support, strengthen, and enhance the quality of care in this vital federal health insurance program that guarantees all Medicare beneficiaries affordable health care that meets their needs.
