Sets forth the rule for consideration of H.R. 5122 (National Defense Authorization Act for Fiscal Year 2007).

Actions Timeline

Res. 806 the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mrs. Matsui demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day.
