

## HRES 896

Providing for consideration of the resolution (H. Res. 895) supporting intelligence and law enforcement programs to track terrorists and terrorist finances conducted consistent with Federal law and with appropriate Congressional consultation and specifically condemning the disclosure and publication of classified information that impairs the international fight against terrorism and needlessly exposes Americans to the threat of further terror attacks by revealing a crucial method by which terrorists are traced through their finances.

## Actions Timeline

- **Jun 29, 2006:** The House Committee on Rules reported an original measure, H. Rept. 109-539, by Mr. Sessions.
- **Jun 29, 2006:** Rule provides for consideration of H. Res. 895 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit. Measure will be considered read. Bill is closed to amendments.
- **Jun 29, 2006:** Placed on the House Calendar, Calendar No. 207.
- **Jun 29, 2006:** Considered as privileged matter. (consideration: CR H4817-4828)
- **Jun 29, 2006:** DEBATE - The House proceeded with one hour of debate on H. Res. 896.
- **Jun 29, 2006:** POSTPONED PROCEEDINGS - At the conclusion of debate on the resolution the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Ms. Slaughter demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Jun 29, 2006:** Considered as unfinished business. (consideration: CR H4827-4828)
- **Jun 29, 2006:** On ordering the previous question Agreed to by the Yeas and Nays: 222 - 193 (Roll no. 350). (text as passed House: CR H4817-4818)
- **Jun 29, 2006:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 220 - 195 (Roll no. 351).
