## Summary (as of May 21, 2008)

Affirms the House of Representatives' commitment to promoting maternal health and child survival at home and abroad through greater international investment and participation.

Recognizes maternal health and child survival as fundamental to the well-being of families and societies and to global development and prosperity.

- **May 21, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **May 19, 2008:** Ms. Schakowsky moved to suspend the rules and agree to the resolution, as amended.
- **May 19, 2008:** Considered under suspension of the rules. (consideration: CR H4124-4127)
- **May 19, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1022.
- **May 19, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Smith (NJ) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Mar 5, 2008:** Introduced in House
- **Mar 5, 2008:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
