Summary (as of Apr 10, 2008)

Sets forth the rule for consideration of H.R. 2537 (Beach Protection Act of 2007).

Actions Timeline

- **Apr 10, 2008:** Considered as privileged matter. (consideration: CR H2175-2176)
- **Apr 10, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1083.
- **Apr 10, 2008:** The previous question was ordered without objection.
- **Apr 10, 2008:** POSTPONED PROCEEDINGS - At the end of debate on the H. Res. 1083, the Chair put the question on adoption, and by voice vote, announced that the yeas had prevailed. Mrs. Matsui demanded the yeas and nays and the Chair postponed further proceedings on the question until later in the legislative day.
- **Apr 10, 2008:** Considered as unfinished business.
- **Apr 10, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 224 - 192 (Roll no. 179).
- **Apr 10, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 224 - 192 (Roll no. 179).
- **Apr 10, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 8, 2008:** Introduced in House
- **Apr 8, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-572, by Ms. Matsui.
- **Apr 8, 2008:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill.
- **Apr 8, 2008:** Placed on the House Calendar, Calendar No. 200.
