Summary (as of May 8, 2008)

Recognizes the contributions of nurses to the U.S. health care system. Expresses support for the goals and ideals of National Nurses Week.

- **May 8, 2008:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by voice vote.(text: CR 5/6/2008 H3064)
- **May 8, 2008:** On motion to suspend the rules and agree to the resolution Agreed to by voice vote. (text: CR 5/6/2008 H3064)
- **May 8, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **May 6, 2008:** Mr. Green, Gene moved to suspend the rules and agree to the resolution.
- **May 6, 2008:** Considered under suspension of the rules. (consideration: CR H3064-3067)
- **May 6, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1086.
- **May 6, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Frelinghuysen objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Apr 9, 2008:** Referred to the Subcommittee on Health.
