Summary (as of Sep 17, 2007)

(This measure has not been amended since it was reported to the House on May 17, 2007. The summary of that version is repeated here.)

Carl Sandburg Home National Historic Site Boundary Revision Act of 2007 - Authorizes the Secretary of the Interior to acquire from willing sellers by donation, purchase with donated or appropriated funds, or exchange not more than 110 acres of certain land, water, or interests in land and water to be added to the Carl Sandburg Home National Historic Site.

Permits the Secretary, in order to preserve the historic character and landscape of the Site, to also acquire up to five acres of land for the development of a visitor center and visitor parking area adjacent to or in the vicinity of the Site.

Instructs the Secretary, upon the acquisition of any land or interest in land under this Act, to revise the boundary of the Site to reflect the acquisition. Requires any land added to the Site by this Act to be administered as part of the Site in accordance with applicable laws and regulations.

- **Jul 12, 2007:** Committee on Energy and Natural Resources Senate Subcommittee on National Parks. Hearings held. With printed Hearing: S.Hrg. 110-158.
- **May 24, 2007:** Received in the Senate and Read twice and referred to the Committee on Energy and Natural Resources.
- **May 23, 2007:** Rule H. Res. 429 passed House.
- **May 23, 2007:** Considered under the provisions of rule H. Res. 429. (consideration: CR H5648-5654)
- **May 23, 2007:** Rule provides for consideration of H.R. 1100 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. A specified amendment is in order. All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Natural Resources now printed in the bill.
- **May 23, 2007:** The Speaker designated the Honorable Ed Pastor to act as Chairman of the Committee.
- **May 23, 2007:** House resolved itself into the Committee of the Whole House on the state of the Union pursuant to H. Res. 429 and Rule XVIII.
- **May 23, 2007:** GENERAL DEBATE - The Committee of the Whole proceeded with one hour of general debate on H.R. 1100.
- **May 23, 2007:** DEBATE - Pursuant to the provisions of H. Res. 429, the Committee of the Whole proceeded with 10 minutes of debate on the Bishop (UT) amendment numbered 1.
- **May 23, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Bishop (UT) amendment numbered 1, the Chair put the question on adoption of the amendment and by voice vote, announced that the noes had prevailed. Mr. Bishop (UT) demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **May 23, 2007:** DEBATE - Pursuant to the provisions of H. Res. 429, the Committee of the Whole proceeded with 10 minutes of debate on the Bishop (UT) amendment numbered 2.
- **May 23, 2007:** DEBATE - Pursuant to the provisions of H. Res. 429, the Committee of the Whole proceeded with 10 minutes of debate on the Heller amendment.
- **May 23, 2007:** POSTPONED PROCEEDINGS - At the conclusion of debate on the Heller amendment, the Chair put the question on adoption of the amendment and by voice vote, announced that the noes had prevailed. Mr. Heller demanded a recorded vote and the Chair postponed further proceedings on the question of adoption of the amendment until later in the legislative day.
- **May 23, 2007:** Mr. Grijalva moved that the Committee rise.

- **May 23, 2007:** The House rose from the Committee of the Whole House on the state of the Union to report H.R. 1100.
- **May 23, 2007:** The previous question was ordered pursuant to the rule. (consideration: CR H5666)
- **May 23, 2007:** The House adopted the amendment in the nature of a substitute as agreed to by the Committee of the Whole House on the state of the Union. (text: CR H5651)
- **May 23, 2007:** Mr. Pearce moved to recommit with instructions to Natural Resources. (consideration: CR H5666-5667; text: CR H5666-5667)
- **May 23, 2007:** DEBATE - The House proceeded with 10 minutes of debate on the Pearce motion to recommit with instructions. The instructions contained in the motion seek to require the bill to be reported back to the House with an

amendment to prohibit the Secretary of the Interior from using eminent domain to acquire land, water, or interests in land or water under section 3 of the bill.
