Summary (as of May 21, 2008)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Expresses support for: (1) designation of a National Autism Awareness Month; and (2) devoting new resources to researching the root causes of autism, identifying the best methods of early intervention and treatment, expanding programs for individuals with autism, and promoting understanding of their special needs.

Commends parents and relatives for providing for the special needs of children with autism.

Stresses the need to begin early intervention services.

Recognizes: (1) the shortage of appropriately trained teachers to teach, assist, and respond to special needs students; and (2) the importance of worker training programs tailored to the needs of developmentally disabled persons.

- **May 19, 2008:** Mr. Wynn moved to suspend the rules and agree to the resolution.
- **May 19, 2008:** Considered under suspension of the rules. (consideration: CR H4120-4121)
- **May 19, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1106.
- **May 19, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Smith (NJ) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Apr 15, 2008:** Referred to the Subcommittee on Health.
- **Apr 14, 2008:** Introduced in House
- **Apr 14, 2008:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
