Sets forth the rule for consideration of H.R. 5715 (Ensuring Continued Access to Student Loans Act of 2008).

Actions Timeline

- **Apr 16, 2008:** Considered as privileged matter. (consideration: CR H2362-2367)
- **Apr 16, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1107.
- **Apr 16, 2008:** POSTPONED PROCEEDINGS - At the end of debate on H. Res. 1107, the Chair put the question on ordering the previous question, and by voice vote, announced that the ayes had prevailed. Mr Lincoln Diaz-Balart (FL) demanded the yeas and nays and the Chair postponed further proceedings on the question of ordering the previous question until later in the legislative day.
- **Apr 16, 2008:** Considered as unfinished business. (consideration: CR H2374-2375)
- **Apr 16, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 218 - 198 (Roll no. 194). (consideration: CR H2367, H2375)
- **Apr 16, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 192 (Roll no. 195). (text: CR H2362)
- **Apr 16, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 16, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 192 (Roll no. 195). (text: CR H2362)
- **Apr 15, 2008:** Introduced in House
- **Apr 15, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-590, by Ms. Castor.
- **Apr 15, 2008:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The amendment printed in Part A of the report of the Committee on Rules accompanying this resolution shall be considered as adopted in the House and in the Committee of the Whole.
- **Apr 15, 2008:** Placed on the House Calendar, Calendar No. 206.
