### Summary (as of Apr 30, 2008)

Makes it in order at any time on the legislative day of Thursday, May 1, 2008, for the Speaker of the House of Representatives to entertain motions that the House suspend the rules relating to the following measures: (1) H.R. 5715 (Ensuring Continued Access to Student Loans Act of 2008); (2) H.R. 493 (Genetic Information Nondiscrimination Act of 2008); and (3) a bill to provide for a temporary extension of programs authorized by the Farm Security and Rural Investment Act of 2002.

## Actions Timeline

- **May 1, 2008:** Considered as privileged matter. (consideration: CR H2953-2956)
- **May 1, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1167.
- **May 1, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 1167, the Chair put the question on ordering the previous question and by voice vote, announced that the noes had prevailed. Ms. Slaughter demanded the yeas and nays which were ordered and pursuant to the rule, the Chair postponed further proceedings on the resolution until later in the legislative day.
- **May 1, 2008:** Considered as unfinished business. (consideration: CR H2980-2981)
- **May 1, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 226 - 190 (Roll no. 235). (consideration: CR H2956, H2980-2981)
- **May 1, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 189 (Roll no. 236).(text: CR H2953)
- **May 1, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 228 - 189 (Roll no. 236). (text: CR H2953)
- **May 1, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 30, 2008:** Introduced in House
- **Apr 30, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-614, by Ms. Slaughter.
- **Apr 30, 2008:** The amendment authorized the Speaker to entertain motions that the House suspend the rules at any time on the legislative day of May 1, 2008 relating to the following measures: H.R. 5715, H.R. 493, and a bill to provide for a temporary extension of programs authorized by the Farm Security and Rural Investment Act of 2002.
- **Apr 30, 2008:** Placed on the House Calendar, Calendar No. 213.
