Summary (as of Feb 16, 2007)

Habeas Corpus Preservation Act - Provides that nothing in the Military Commissions Act of 2006 shall affect the right of any U.S. resident to habeas corpus.

### **Actions Timeline**

- Mar 19, 2007: Referred to the Subcommittee on the Constitution, Civil Rights, and Civil Liberties.
- Feb 16, 2007: Introduced in House
- Feb 16, 2007: Referred to the Committee on Armed Services, and in addition to the Committees on the Judiciary, and Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
