- **Jun 10, 2008:** Considered as privileged matter. (consideration: CR H5119-5125, H5141-5142)
- **Jun 10, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1253.
- **Jun 10, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1253, the Chair put the question on ordering the previous question on H.Res. 1253 and by voice vote, announced that the ayes prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H.Res. 1253 until later in the legislative day.
- **Jun 10, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 227 - 185 (Roll no. 391). (consideration: CR H5141)
- **Jun 10, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 227 - 187 (Roll no. 392).(text: CR H5119)
- **Jun 10, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 227 - 187 (Roll no. 392). (text: CR H5119)
- **Jun 10, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 9, 2008:** Introduced in House
- **Jun 9, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-703, by Ms. Matsui.
- **Jun 9, 2008:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Transportation and Infrastructure now printed in the bill.
- **Jun 9, 2008:** Placed on the House Calendar, Calendar No. 232.
