- Sep 15, 2008: Ms. Bordallo moved to suspend the rules and agree to the resolution.
- Sep 15, 2008: Considered under suspension of the rules. (consideration: CR H8065-8067)
- Sep 15, 2008: DEBATE The House proceeded with forty minutes of debate on H. Res. 1255.
- Sep 15, 2008: At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Cole (OK) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- Jul 2, 2008: Referred to the Subcommittee on Military Personnel.
- Jun 10, 2008: Introduced in House
- Jun 10, 2008: Referred to the House Committee on Armed Services.
