Sets forth the rule for consideration of the bill (H.R. 5749) to provide for a program of emergency unemployment compensation.

Mr. Hastings(WA) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.

In lieu of the amendment in the nature of a substitute recommended by the Committee on Ways and Means now printed in the bill, the amendment in the nature of a substitute printed in the report of the Committee on Rules accompanying this resolution shall be considered as adopted.
