110 HR 5876	Procedurally related	Jun 24, 2008: DEBATE - The House proceeded with ten minutes of debate on the Bachmann motion to recommit with instructions. The instructions contained in the motion seek to add an amendment requiring parents or legal guardians to give consent before prescription medication is administered to children. During the course of debate, further proceedings on H.R. 5876 were postponed until a time to be announced.
