- Jun 17, 2008: Introduced in House
- Jun 17, 2008: The House Committee on Rules reported an original measure, H. Rept. 110-718, by Mr. McGovern.
- Jun 17, 2008: All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The amendment in the nature of a substitute recommended by the Committee on Oversight and Government Reform now printed in the bill shall be considered as adopted.
