Medigap Access Improvement Act of 2007 - Amends title XVIII (Medicare) of the Social Security Act to provide for guaranteed issue of replacement Medicare supplemental (Medigap) policies for beneficiaries under age 65 upon first enrolling under part B (Supplementary Medical Insurance) of Medicare.

- Mar 1, 2007: Introduced in House
- Mar 1, 2007: Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
