Supports the goals and ideals of National Save for Retirement Week (October 19-25, 2008).

Supports the need to raise public awareness of efficiently utilizing substantial tax revenues that currently subsidize retirement savings, revenues in excess of \$170 billion for the 2007 Fiscal Year Budget.

Supports the need to raise public awareness of the importance to save adequately for retirement and the availability of tax-preferred employer-sponsored retirement savings vehicles.

- **Jun 26, 2008:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by voice vote.(text: CR 6/24/2008 H5932)
- **Jun 26, 2008:** On motion to suspend the rules and agree to the resolution Agreed to by voice vote. (text: CR 6/24/2008 H5932)
- **Jun 26, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 24, 2008:** Ms. Schwartz moved to suspend the rules and agree to the resolution.
- **Jun 24, 2008:** Considered under suspension of the rules. (consideration: CR H5932-5934)
- **Jun 24, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1294.
- **Jun 24, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Johnson, Sam objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Jun 23, 2008:** Introduced in House
- **Jun 23, 2008:** Referred to the House Committee on Ways and Means.
