Sets forth the rule for consideration of the bill (H.R. 3195) to restore the intent and protections of the Americans with Disabilities Act of 1990.

Actions Timeline

- **Jun 25, 2008:** Considered as privileged matter. (consideration: CR H6025-6028)
- **Jun 25, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1299.
- **Jun 25, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 1299, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Sessions demanded the yeas and nays and the Chair postponed further proceedings on the question until a time to be announced.
- **Jun 25, 2008:** Considered as unfinished business. (consideration: CR H6030-6031)
- **Jun 25, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 221 - 194 (Roll no. 453). (consideration: CR H6028, H6030-6031)
- **Jun 25, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H6025)
- **Jun 25, 2008:** On agreeing to the resolution Agreed to by voice vote. (text: CR H6025)
- **Jun 25, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 24, 2008:** Introduced in House
- **Jun 24, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-733, by Ms. Sutton.
- **Jun 24, 2008:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The amendment in the nature of a substitute recommended by the Committee on Education and Labor now printed in the bill shall be considered as adopted.
- **Jun 24, 2008:** Placed on the House Calendar, Calendar No. 243.
