Summary (as of Mar 5, 2007)

Relief and Elimination of the Medicare Enrollment Deadline Penalty (REMEDY) Act of 2007 - Amends part D (Voluntary Prescription Drug Benefit Program) of title XVIII (Medicare) of the Social Security Act to: (1) postpone the Medicare part D late enrollment penalty until after 2007; and (2) eliminate such penalties for low-income subsidy-eligible individuals for periods after 2007.

Directs the Secretary of Health and Human Services to establish a method for providing rebates of late enrollment penalties paid for months before the enactment of this Act.

Actions Timeline

- **Mar 7, 2007:** Referred to the Subcommittee on Health.
- **Mar 6, 2007:** Referred to the Subcommittee on Health.
- **Mar 5, 2007:** Introduced in House
- **Mar 5, 2007:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
