Summary (as of Jul 31, 2008)

Recognizes the importance of connecting foster youth to the workforce through internship programs that provide foster youth the foundation upon which to build their careers and to be successful members of the work force.

Encourages employers of all sectors and federal, state, and local governmental agencies to increase employment of the young men and women who have been discharged from foster care in the United States.

- **Jul 31, 2008:** Motion to reconsider laid on the table Agreed to without objection.

- **Jul 29, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1332.
- **Jul 29, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Kline (MN) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
