Sets forth the rule for consideration of the bill (H.R. 5959) to authorize appropriations for fiscal year 2009 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System.

Mr. Hastings (WA) demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.

- **Jul 16, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 15, 2008:** Introduced in House
- **Jul 15, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-759, by Mr. Hastings (FL).
- **Jul 15, 2008:** All points of order against consideration of the bill are waived except those arising under clause 9 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Permanent Select Committee on Intelligence now printed in the bill.
