Summary (as of Mar 6, 2007)

Amends the Food Stamp Act of 1977 to obligate funds for the administrative costs of commodity distributions on Indian reservations.

Directs the Secretary of Agriculture to carry out an annual survey of foods purchased by school authorities with federal cash assistance.

Amends the Richard B. Russell National School Lunch Act to direct the transfer of funds in FY2007-FY2009 for the free lunch and breakfast eligibility program.
