



# HR 1347

To extend the period during which members of the Armed Forces deployed in contingency operations may request and receive reimbursement for helmet pads, which are designed to protect the wearer from bomb blasts and non-ballistic impacts, that are purchased by such members.

Reagan National Defense Authorization Act for Fiscal Year 2005 to extend the period during which members of the Armed Forces deployed in connection with Operations Noble Eagle, Enduring Freedom, or Iraqi Freedom may request and receive reimbursement for purchasing protective helmet pads.
