Summary (as of Jul 22, 2008)

Sets forth the rule for consideration of the Senate amendment to H.R. 5501 (Tom Lantos and Henry J. Hyde United States Global Leadership Against HIV/AIDS, Tuberculosis, and Malaria Reauthorization Act of 2008).

Actions Timeline

- **Jul 24, 2008:** Considered as privileged matter. (consideration: CR H7065-7071, H7079)
- **Jul 24, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1362.
- **Jul 24, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1362, the Chair put the question on ordering the previous question, and by voice vote announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart (FL) demanded the yeas and nays, and further proceedings on ordering the previous question were postponed until later in the legislative day.
- **Jul 24, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 231 - 185 (Roll no. 526). (consideration: CR H7069-7071, H7079; text: CR H7070)
- **Jul 24, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H7065)
- **Jul 24, 2008:** On agreeing to the resolution Agreed to by voice vote. (text: CR H7065)
- **Jul 24, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 22, 2008:** Introduced in House
- **Jul 22, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-766, by Mr. Hastings (FL).
- **Jul 22, 2008:** Upon the adoption of this resolution it shall be in order to take from the Speaker's table the bill H.R. 5501, with the Senate amendment thereto, and consider in the House a motion offered by the chairman of the Committee on Foreign Affairs or his designee, that the House concur in the Senate amendment. The motion shall be debatable for one hour, equally divided and controlled and the previous question shall be considered as ordered on the motion to its adoption without intervening motion.
- **Jul 22, 2008:** Placed on the House Calendar, Calendar No. 251.
