Summary (as of Jul 24, 2008)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Provides that House of Representatives procedures under the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 for the consideration of proposed legislation by the President to respond to a Medicare funding warning shall not apply during the remainder of the 110th Congress.

Actions Timeline

- **Jul 24, 2008:** Considered as privileged matter. (consideration: CR H7122-7132)
- **Jul 24, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1368.
- **Jul 24, 2008:** The previous question was ordered without objection. (consideration: CR H7132)
- **Jul 24, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1368, the Chair put the question on adoption and by voice vote announced the ayes had prevailed. Mr. Drier (WA) demanded the yeas and nays and the Chair postponed further proceedings on H.Res. 1368 until later in the legislative day.
- **Jul 24, 2008:** Considered as unfinished business. (consideration: CR H7133-7134)
- **Jul 24, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 231 - 184 (Roll no. 532).(text: CR H7122)
- **Jul 24, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 231 - 184 (Roll no. 532). (text: CR H7122)
- **Jul 24, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 23, 2008:** Introduced in House
- **Jul 23, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-769, by Mr. Hastings (FL).
- **Jul 23, 2008:** The resolution provides that section 803 of the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 shall not apply during the remainder of the 110th Congress.
- **Jul 23, 2008:** Placed on the House Calendar, Calendar No. 254.
