- **Sep 17, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 17, 2008:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution, as amended Agreed to by voice vote.
- **Sep 17, 2008:** On motion to suspend the rules and agree to the resolution, as amended Agreed to by voice vote.
- **Sep 15, 2008:** Mr. Hinojosa moved to suspend the rules and agree to the resolution, as amended.
- **Sep 15, 2008:** Considered under suspension of the rules. (consideration: CR H8092-8094; text of measure as introduced: CR H8092)
- **Sep 15, 2008:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 1372.
- **Sep 15, 2008:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Bishop (UT) objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was withdrawn.
- **Jul 23, 2008:** Introduced in House
- **Jul 23, 2008:** Referred to the House Committee on Education and Labor.
