Sets forth the rule for consideration of the bill (H.R. 6599) making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2009.

Mr. Hastings(WA) demanded the yeas and nays, and the Chair postponed further proceedings on adoption until later in the legislative day.

Notwithstanding clause 11 of rule XVIII, no amendment to the bill shall be in order except those printed in the portion of the Congressional Record designated for that purpose in clause 8 of rule XVIII in a daily issue dated July 30, 2008, or earlier and except pro forma amendments for the purpose of debate.
