Sets forth the rule for consideration of the bill (H.R. 1338) to amend the Fair Labor Standards Act of 1938 to provide more effective remedies to victims of discrimination in the payment of wages on the basis of sex.

Actions Timeline

- **Jul 31, 2008:** Considered as privileged matter. (consideration: CR H7637-7642)
- **Jul 31, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1388.
- **Jul 31, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1388, the Chair put the question on adoption of ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart (FL) demanded the yeas and nays, and the Chair postponed further proceedings on adoption until later in the legislative day.

- **Jul 31, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 232 - 191 (Roll no. 547). (consideration: CR H7642, H7676)
