110 HR 6899	Procedurally related	Nov 18, 2008: Read the second time. Placed on Senate Legislative Calendar under General Orders. Calendar No. 1118 under authority of the order of the Senate of 11/17/2008.

Sets forth the rule for consideration of the bill (H.R. 6899) to advance the national security interests of the United States by reducing its dependency on oil through renewable and clean, alternative fuel technologies while building a bridge to the future through expanded access to Federal oil and natural gas resources, revising the relationship between the oil and gas industry and the consumers who own those resources and deserve a fair return from the development of publicly owned oil and gas, ending tax subsidies for large oil and gas companies, and facilitating energy efficiencies in the building, housing, and transportation sectors.

Actions Timeline

- Sep 16, 2008: The House Committee on Rules reported an original measure, H. Rept. 110-853, by Ms. Slaughter.
- Sep 16, 2008: Rule provides for consideration of H.R. 6899 with 3 hours of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit. Measure will be considered read. Bill is closed to amendments.
- Sep 16, 2008: Placed on the House Calendar, Calendar No. 265.
- Sep 16, 2008: By the direction of the Committee on Rules, Ms. Slaughter called up H.Res. 1433 and asked for its immediate consideration.
- Sep 16, 2008: POINT OF ORDER Mr. Cantor raised a point of order against the provisions of H.Res. 1433 because it violates the Congressional Budget Act. The Chair announced that the disposition of the point of order would be solved by the question of consideration of H.Res. 1433. The House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration.
- Sep 16, 2008: Will the House now consider the resolution Agreed to by the Yeas and Nays: 230 180 (Roll no. 593).
- Sep 16, 2008: Considered as privileged matter. (consideration: CR H8152-8157, H8157-8168)
- Sep 16, 2008: DEBATE The House proceeded with one hour of debate on H. Res. 1433.
- Sep 16, 2008: POSTPONED PROCEEDINGS At the conclusion of debate on H. Res. 1433, the Chair put the question on adoption of ordering the previous question and by voice vote announced that the noes had prevailed. Ms. Slaughter demanded the yeas and nays, and further proceedings on the question of adoption were postponed until later in the legislative day.
- Sep 16, 2008: Considered as unfinished business. (consideration: CR H8178-8179)
- Sep 16, 2008: On ordering the previous question Agreed to by the Yeas and Nays: 238 185 (Roll no. 595).
- Sep 16, 2008: Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 229 194 (Roll no. 596).(text: CR H8152)
- Sep 16, 2008: On agreeing to the resolution Agreed to by the Yeas and Nays: 229 194 (Roll no. 596). (text: CR H8152)
