Sets forth the rule for consideration of the bill (H.R. 3036) to amend the Elementary and Secondary Education Act of 1965 regarding environmental education.

## Actions Timeline

- **Sep 18, 2008:** Considered as privileged matter. (consideration: CR H8402-8405, H8430-8432)
- **Sep 18, 2008:** DEBATE - The House proceeded with one hour of debate on H. Res. 1441.
- **Sep 18, 2008:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 1441, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question on H.Res. 1441 until later in the legislative day.
- **Sep 18, 2008:** On ordering the previous question Agreed to by the Yeas and Nays: 227 - 188 (Roll no. 610). (consideration: CR H8430-8432)
- **Sep 18, 2008:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 221 - 182 (Roll no. 611).(text: CR H8402-8403)
- **Sep 18, 2008:** On agreeing to the resolution Agreed to by the Yeas and Nays: 221 - 182 (Roll no. 611). (text: CR H8402-8403)
- **Sep 18, 2008:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 16, 2008:** Introduced in House
- **Sep 16, 2008:** The House Committee on Rules reported an original measure, H. Rept. 110-854, by Ms. Castor.
- **Sep 16, 2008:** The rule waives all points of order against consideration of the bill except clauses 9 and 10 of rule XXI. The rule provides that the amendment in the nature of a substitute recommended by the Committee on Education and Labor now printed in the bill shall be considered as an original bill for the purpose of amendment.
- **Sep 16, 2008:** Placed on the House Calendar, Calendar No. 266.
